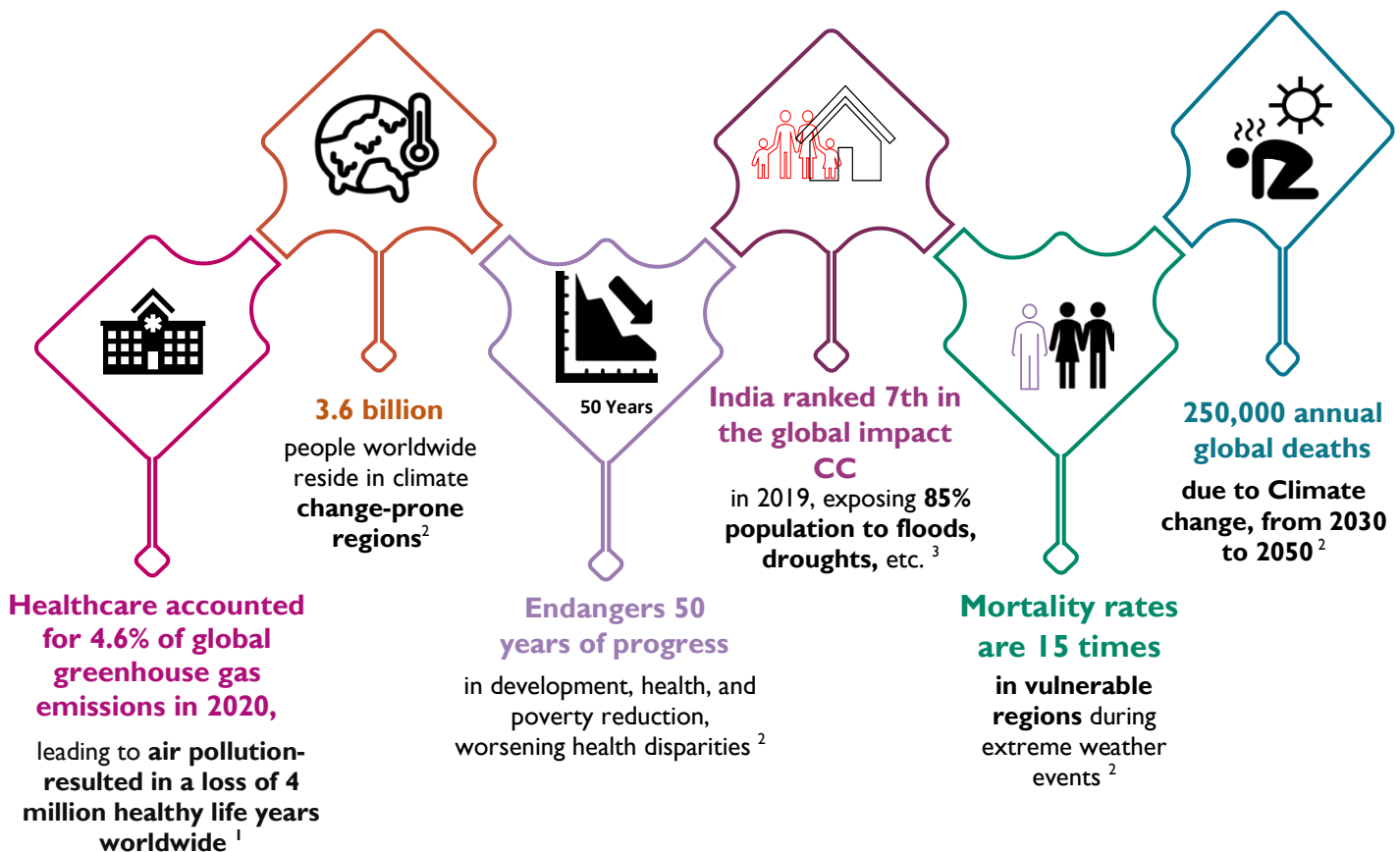

Need to Act on Climate Change

Climate change stands as one of the most pressing challenges confronting global public health today. It has emerged as a significant threat, disrupting the intricate balance of climate, weather patterns, and life itself as temperatures and precipitation patterns shift.

The Solution

The **National Programme on Climate Change and Human Health (NPCCHH)** is a flagship programme of the Ministry of Health and Family Welfare (MoHFW), strengthening the health system response to climate change in the country. The goal of the programme is to reduce morbidity, mortality, injuries, and health vulnerability to climate variability and extreme weather events. The strategic approach is aligned under five pillars including increasing general awareness, building the capacity of the healthcare workforce, strengthening the health systems structurally and functionally, collaborative partnership and research & development.

This will strengthen our health system's adaptive capacity to increase and compound the impacts of various climate-sensitive diseases and health impacts ranging from increased vector and waterborne diseases, food insecurity, heatwaves, flooding, and other extreme weather events.

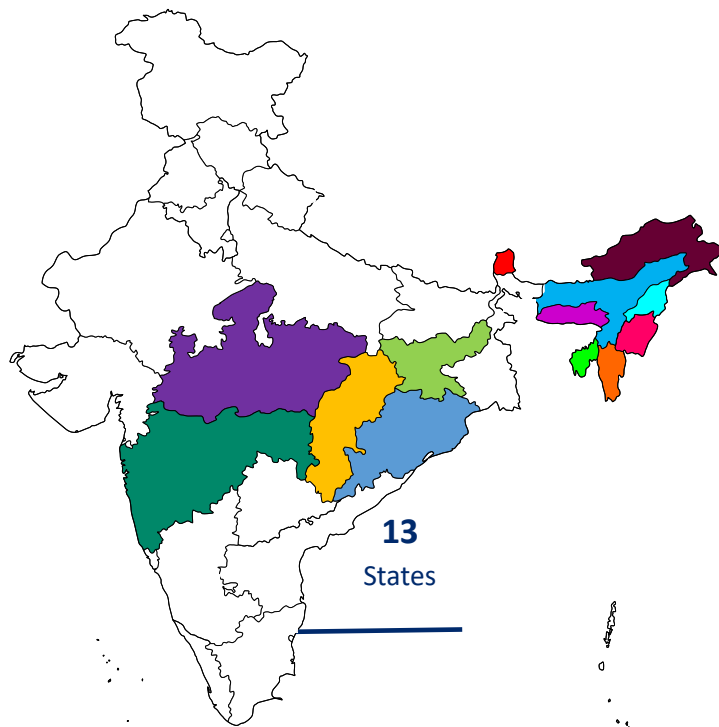

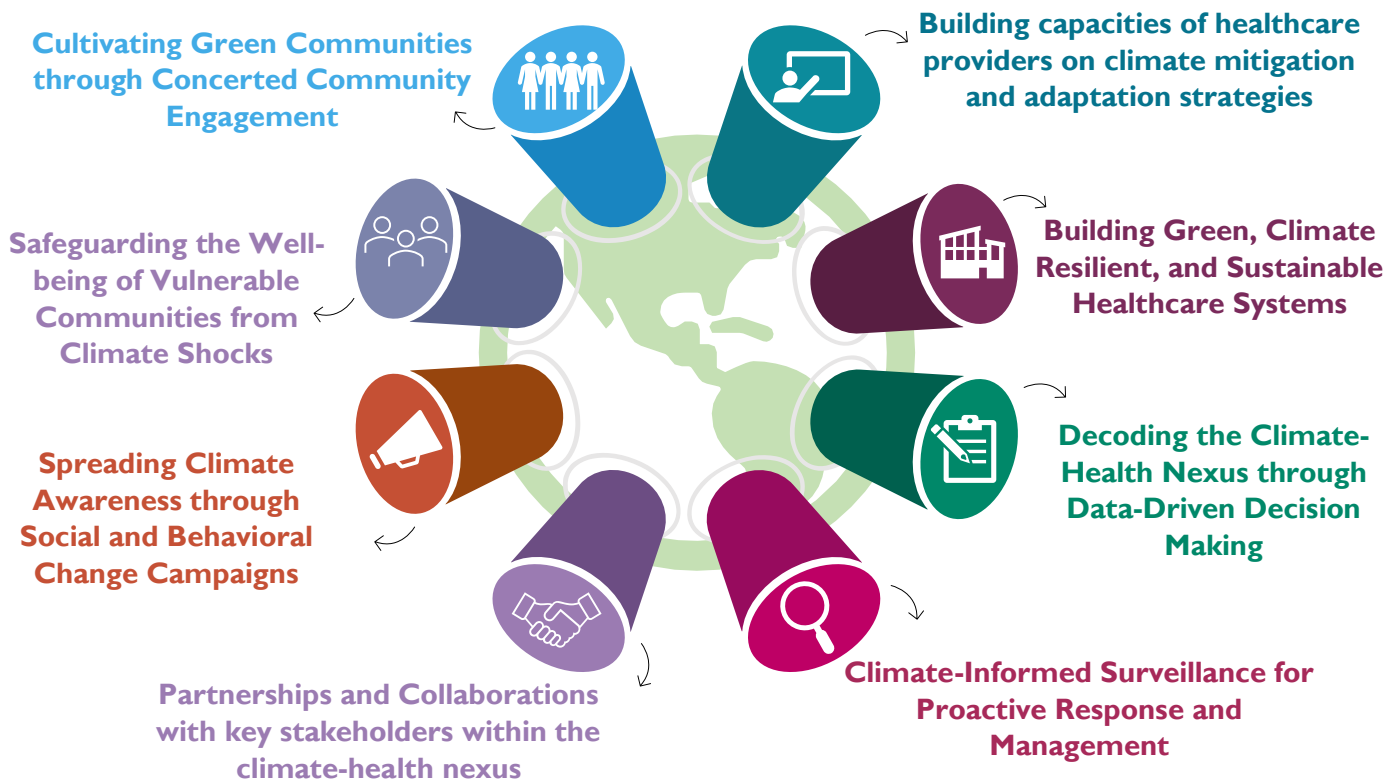
